Preface

Independent Agency for Accreditation and Rating (IAAR) was established in 2011 in the form of a non-profit organization with the purpose of improving national system of education quality assurance. This document is a Second Plan of Strategic Development.

Since the establishment, the IAAR has passed an evolutionary way of development, which is inherent to all young quality assurance organizations. At the same time the establishment and modernization of the whole system of independent accreditation in Kazakhstan took place. Today IAAR is an established and recognized Agency of external quality assurance in education both in Kazakhstan and abroad.

Aims and objectives of the Strategic Development Plan for 2011-2015 have been performed. During this period, 33 organizations of education have passed the institutional accreditation and 849 educational programs of different levels of education have been accredited. All standards of institutional and specialized accreditation of educational organizations are harmonized with the revised and approved in Yerevan (2015) Standards and guidelines for quality assurance in the European Higher Education Area (ESG) and standards of World Federation for Medical Education (WFME). Today the Agency incorporates the Commission on Appeals and Complaints Consideration, as well as three Expert Councils.

During the period from 2011 to 2015, 175 foreign and 1 848 national experts were prepared, including:

- academic experts of higher education 452;
- experts from the number of employers 216;
- experts of Technical and Vocational Education (TVE) 941;
- experts from the number of students 55;
- experts in the field of medical education 184.

Within the rating research, a technology of ranking of universities and institutions of Technical and Professional Education has developed and implemented, taking into account the world experience and national features of educational system.

The Strategic Development Plan of the IAAR assumes implementation of goals and objectives from 2016 to 2020.

The present Strategic Plan has been elaborated by the IAAR staff, and with the help of members of Accreditation Council and the Expert Councils of the IAAR. A draft of the development plan was discussed at the meeting of Accreditation Council of the IAAR and recommended for approval in December 2015.

Constant support and promotion of a culture of quality in education in order to increase the competitiveness of Kazakhstan's society and education through appropriate external quality assurance.

4. Conducting 2-level training seminars for national experts (representatives of the university community, employers and students).

6. Further training of the IAAR staff on a permanent basis. Conducting workshops (conferences, training courses, etc.) with the attraction of leading experts in the field of quality assurance.

7. Improving the feedback mechanisms with experts of the IAAR.

4.2 Carrying out rating study in higher, technical and vocational education

Objectives:

4.2.1 Improvement of the methodology for rating and ranking of HEIs and TVE organizations

Events:

1. Holding the training seminars on methodology of rating and ranging of higher education institutions and the organizations of TVE.

2. Carrying out an independent rating research of study programs of higher education institutions of the Republic of Kazakhstan according to the directions and levels of training of specialists.

3. Carrying out an independent rating research of study programs of the TVE organizations of the Republic of Kazakhstan according to the directions and levels of training of specialists in regions.

4. Carrying out an independent rating research of the teaching staff of HEIs and teachers of the TVE organizations.

Key indicators:

- Holding not less than two seminars on methodology of rating and ranking of HEIs and the TVE organizations in one year.

- By 2020 all higher education institutions participate in an independent rating of HEIs according to the directions and levels of training of specialists.

2. The analysis of the results of feedback with the accredited organizations of education.

3. The analysis of results of post-accreditation monitoring study of the accredited organizations of education and/or educational programs.

4. The analysis of results of feedback with experts of the IAAR

5. The system analysis of implementation of programs of the academic mobility and internationalization of education in the accredited higher education institutions. 6. The system analysis of commercialization of scientific projects in the accredited higher education institutions of the Republic of Kazakhstan.

7. Improvement of system of the statistical analysis based on activity of the IAAR.

8. Continued support of internal system of an assessment of quality

- Annual survey of education stakeholders (education organizations, employers, experts, students).

- Annual analytical reports on the results of the feedback from accredited organizations of education and experts of the IAAR.

- Annual monitoring of internal system of statistics on all activities on a constant basis.

- Modernization of the automated database of national experts, the accredited organizations of education and the accredited educational programs in 2016.

- Analytical report on the implementation of programs of the academic mobility and internationalization of education in the accredited higher education institutions (2016-2017).

- Analytical report on the commercialization of scientific projects in the accredited higher education institutions of the Republic of Kazakhstan (2017-2018).

- Annual statistical report of the IAAR.

4.4 Informing the public about results of an assessment of quality of educational programs and educational organizations

Objectives:

4.4.1 The IAAR as reliable source of informing on quality assurance

Events:

1. Timely informing the public about results of expert commission and the decisions made by Accreditation Council of the IAAR (the website, analytical reports in authorized body in the fields of education, articles in mass media, etc.).

2. Informing public about national system of quality assurance education, procedures of internal quality assurance, improvement of the IAAR institutional and specialized accreditation standards.

3. The publication of results of an independent rating research of higher education institutions and TVE organizations in mass media.

Key indicators:

- Annual publication of the Education.kz magazine for all interested parties.
- Number of the published analytical reports, scientific articles and publications in mass media.
- A website attendance of the IAAR.
- Annual carrying out scientific and practical conference (forum) on quality assurance.

- Participation of the IAAR employees in the events held by national, European, international accreditation agencies and authorized body in the field of education of the Republic of Kazakhstan.

- Annual publication of results of rating research of higher educational institutions and TVE organizations in mass media.

4.5 IAAR as a recognized accreditation body

Objectives:

4.5.1 Confirmation of recognition of the IAAR by authorized body in the field of education of the Republic of Kazakhstan

Events:

1. Each five years confirmation of recognition of the IAAR by authorized body in the field of education of the Republic of Kazakhstan.

Key indicators:

- In 2016 preparation of the documentation for re-recognition procedure by MES RK (National Registry 1).

- In June, 2017 repeated procedure of recognition of MES RK (National Registry 1).

4.5.2 Obtaining a full membership status of the IAAR in ENQA

Events:

1. Preparation of a self-assessment of the IAAR for passing ENQA Review.

Key indicators:

- Submitting the IAAR self-assessment report to ENQA in 2016.
- Site visit of ENQA experts in 2016.
- Results of ENQA Review in 2016.
- Full membership of the IAAR in ENQA in 2017.

4.5.3 Inclusion of the IAAR into the European Quality Assurance Register for Higher Education (EQAR)

Events:

1. Preparation of the IAAR documentation for entry into the EQAR.

Key indicators:

- An application of the IAAR for entry into the EQAR in 2016.

- Inclusion of the IAAR in EQAR after obtaining the status of the full member of ENQA in 2017.

- Recognition of national experts of the IAAR by the European and international agencies of quality assurance.

4.5.4 Recognition of the IAAR by WFME.

Events:

1. Preparation of documents for application for recognition in WFME.

2. Participation of the IAAR in national and international projects on development of medical education.

Key indicators:

- An application of IAAR in WFME in 2016.
- Providing the self-report of the IAAR in WFME in 2016.
- Site visit of experts of WFME in 2016.
- Recognition of the IAAR by WFME in 2017.

4.5.5 Development of national and international cooperation

Events:

1. Participation of the IAAR as recognized accreditation body in national and international projects.

2. Representation of the IAAR in Councils (Committees, Boards) of ENQA and/or INQAAHE and/or APQN.

3. Carrying out the international conference with participation of experts of the international networks on quality assurance (for example, ENQA, INQAAHE, APQN).

4. Participation of the IAAR in national and international projects on development of medical education.

5. Signing of memorandums/agreements with the International public coordinating committee on health care and the Accreditation, Certification and Quality Assurance Institute (ACQUIN).

Key indicators:

- Carrying out the international conference or the international seminar with participation of the international networks on ensuring quality (for example, ENQA, INQAAHE, APQN) each two years.

- Annual participation in the international projects on development of the organizations of medical education.
